A lot was accomplished in 2023. As the world emerged from the clutches of the pandemic, we saw our walk-in patient numbers climb to nearly our pre-Covid levels, close to 100,000 patients in Mt Abu and 40,000 patients at each of our units in Abu Road. More people opted for planned surgeries and treatments that had taken a backseat during the pandemic. More specialists visited the hospital and offered consultations and treatment. We remain extremely grateful to these specialists for their spirit of volunteerism. We were fortunate to host an amazing panel of consultants over the year.

Super-specialty urology services in Mt Abu have picked up after onboarding Dr Vaibhav Vishal, urologist, uro-oncologist and renal transplant surgeon. With Dr Piyushi Sharma in our midst, we have strengthened our gynaecological services and started a fertility clinic.

We prioritised the upgradation of staff skills. About 65 employees underwent a certificate programme in basic life support. Another 35 employees including nurses were certified in infection control practices. A capacity-building programme run in partnership with the premier LV Prasad Eye Institute, Hyderabad, gave our ophthalmology team valuable new insights.

We brought into service a new community mobile clinic sponsored by the Australian Friends for Global Hospital (AF4GH). Our panel of specialists visited far-flung towns to offer patient screening and education. One such event was held every month.

Service at our youngest unit, the Shri Adinath Fateh Global Eye Hospital has picked up tremendously. More than 1800 major surgeries were performed under the able leadership of senior ophthalmologist and in-charge Dr Amit Mohan.

Our pursuit of delivering quality care was strengthened by the acquisition of advanced medical equipment.

We remain steadfast in our vision to provide quality care to all, founded on our guiding values: compassion, care and commitment. 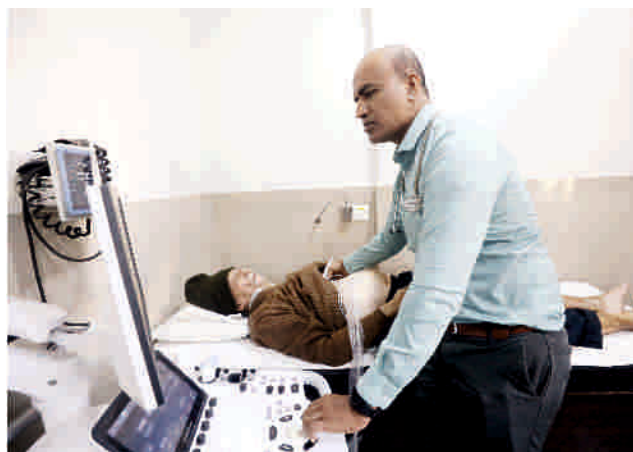

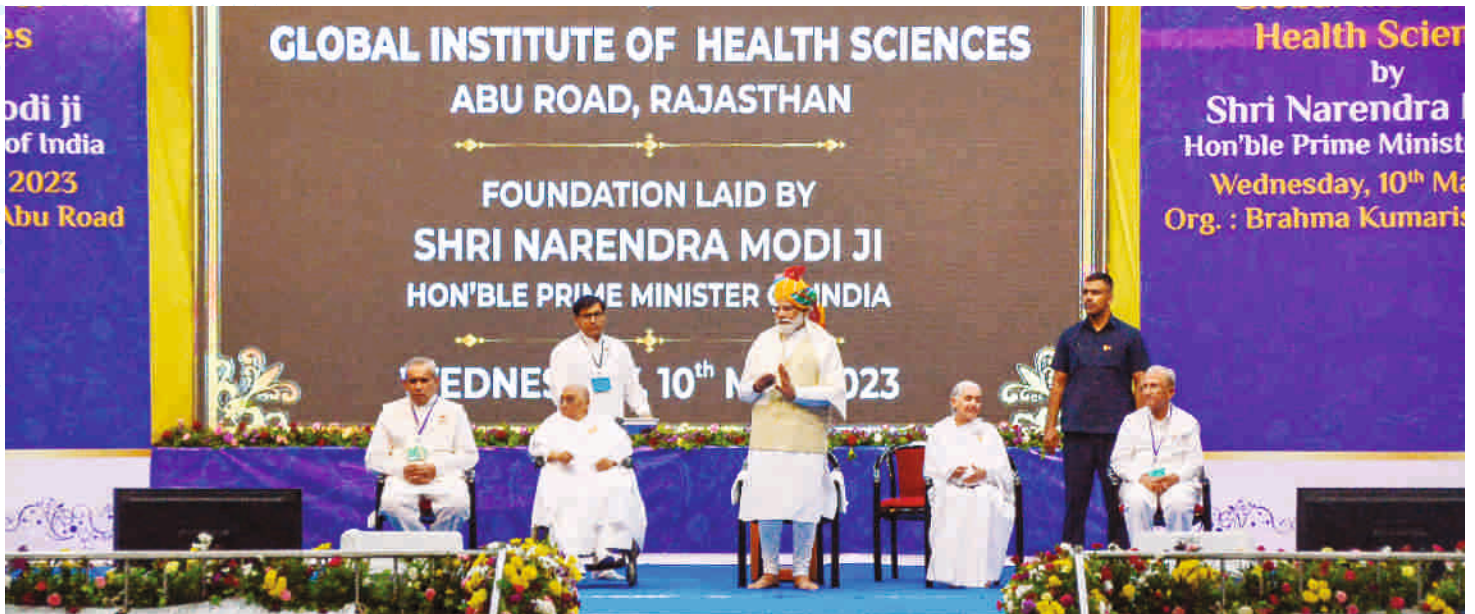


Launch of the Global Institute of Health Sciences, Abu Road

You arrange health camps in surrounding villages, you organise blood donation programmes, and your new super-speciality initiative will take forward these efforts."



The pandemic stretched India's healthcare industry like never before. It set the stage for health care organisations to become more resilient, agile and innovative. This reality sowed a seed in the mind of BK Nirwair, managing trustee of Global Hospital & Research Centre (also, secretary general, Brahma Kumaris). He decided to establish a one-of-a-kind multi-speciality tertiary care hospital at Abu Road.

On May 10, 2023, the foundation stone of the Global Hospital Institute of Health Sciences was laid by India's Prime Minister Narendra Modi, virtually, from the Diamond Jubilee Hall, in the Brahma Kumaris' Shantivan complex at Abu Road. Reverend Dadi Ratan Mohini, the administrative head of the Brahma Kumaris; BK Jayanti, additional administrative head, and director, Europe, Brahma Kumaris; BK Mruthyunjaya, executive secretary, Brahma Kumaris; and Dr Partap Midha, trustee, Global Hospital and Research Centre were by his side.

We're geared up to translate this vision into reality. Our large pool of well-trained medical professionals, including doctors, nurses and paramedical staff will ease the establishment of high quality healthcare facilities. We look to this future-ready workforce to embrace digitalisation and advanced technologies to enhance patient care and outcomes, optimise operations, and make healthcare services more accessible and efficient.

Community Vision



Village Outreach Programme

A doorstep health consultation service for a population of about 80,000 inhabiting 21 villages around Mt Abu.



Started in 1991 alongside the flagship unit of the trust in Mt Abu, the Village Outreach Programme is presently being implemented by Dr Kanak Shrivastava (chief) and Dr Murlidhar Sharma (senior medical officer). It covers villages Aarna-Hetamji, Achalgarh, Chandela (Telapurphali, Ambaveriphali, Bageri, Khadrphali), Jaidra, Jamburi, Jawaingaon,

Kyaria-Takiya, Nichalagarh, Oriya, Salgaon, Shergaon-Utteraj, Siawa, Tuka, Uplagarh.

In FY23, 6,652 patients consulted the doctors visiting the villages. Another 2,661 patients approached the consultants in J Watumull Global Hospital & Research Centre, and 165 village patients were admitted.

Nutritional Programme

A mid-day milk-based mini-meal programme for students in 16 government schools.



Approximately 2,500 students across 16 government schools in these adopted villages took benefit from a milk-based mini-meal programme that has been operational since the late nineties.

Community Service Project

A mobile health consultation service targeting remote areas in district Sirohi.



The delivery of health services to villages was stepped up in 2004 with the launch of the Community Service Project. Starting with one mobile clinic, the service has gradually expanded to three clinics in FY23. Together, the clinics reach out to 97 villages, a population of about 170,000 which is underserved by the existing health services.

Dr Ashok Dave, Dr Sanjeev Dixit, and Dr Dnyaneshwar Bhagoji Game, assisted by three attendants and three drivers, offer consultations to villagers.

In FY23, 24,322 patients consulted the doctors (route 1 and route 2). The age

Community eye care

An outreach initiative to improve the ocular health of the community.



Community eye care initiatives started in the mid-nineties but became more structured in 1997 when the trust became an implementing agency of the government's National Programme for Control of Blindness.

Activities involve conducting screening in villages to identify people (mostly elderly) with mature cataracts. These people are provided with transport to reach the hospital where they are operated on for no charges, and then taken back to their home.

Tuberculosis outreach

Identifying people with tuberculosis in rural India and ensuring they adhere to the WHO-prescribed treatment regimen.

India has the largest share of the global tuberculosis burden. Studies show that people with tuberculosis in rural India stay infectious for twice as long as infected people in urban India. So, speeding up the process of identifying tuberculosis patients in villages and starting their treatment would help contain the spread of disease.

Field workers attached to the Village Outreach Programme and the Community Service Project help identify villagers suffering from tuberculosis. Last year, field workers attached to



In FY23, community teams from the Global Hospital Institute of Ophthalmology, Abu Road, screened 16,781 people at 86 screening events, 9,382 people got their eyes tested, 2,484 people were referred for surgery, 2,476 eventually underwent surgery.

Teams from the Shri Adinath Fateh Global Eye Hospital, Jalore, screened 10,242 people at 42 screening events, 4,006 people got their eyes tested, 1,370 people were referred for surgery, 1,129 eventually underwent surgery.

the Village Outreach Programme helped identify 125 new patients while those attached to the Community Service Project helped identify 111 new patients. In all, 1,030 sputum samples were tested. 201 patients completed the treatment regimen and were declared tuberculosis free. 72 patients were referred. To boost patients' immunity and reduce the chance of a relapse, J Watumull Global Hospital & Research Centre distributes nutritional supplements to those on the tuberculosis treatment regimen. Contributions from GiveIndia help cover this cost.

Medical Education



Diploma in nursing

Global Hospital School of Nursing offers a three year diploma in General Nursing & Midwifery since 2006. The diploma is awarded by the Indian Nursing Association.

In 2022, 78 students (40 boys, 38 girls) were on the rolls of the school while 17 new students (11 boys, 6 girls) were admitted.



Graduate degree in nursing

Saroj Lalji Mehrotra Global Nursing College runs a four year graduate programme in nursing since 2011. The degree is awarded by the Rajasthan University of Health Sciences, Jaipur.

In 2022, 118 students (63 boys, 55 girls) were on the rolls of the college. 30 students (14 boys, 16 girls) joined during the year.



Post graduate degree in ophthalmology

Global Hospital Institute of Ophthalmology offers post graduate training in ophthalmology since 2013. The degree is awarded by the National Board of Examination.

In 2022, Dr Indu Vishnoi joined the course while Dr Ekansh Bansal, Dr Ravinshu Hooda and Dr Aishwarya Hada progressed to the second year, and Dr Pooja Kumari and Dr Akanksha Kumari entered their final year.



Diploma and degree in optometry

Global Hospital Institute of Ophthalmology offers a two-year diploma and a four-year degree in optometry in association with Singhanian University.

In 2022, four students gained admission for the diploma course while 11 students were enrolled for the degree programme.

Another five students were admitted for the graduate programme directly in the third year by lateral entry. Three of those pupils were simultaneously enrolled for a fellowship in optometry.



Student observerships



J Watumull Global Hospital & Research Centre gives students of various disciplines of medicine (and qualified medical and para-medical professionals) the opportunity to undergo observerships. Observers see the working of one or more departments, including staff interactions with patients as well as their handling of equipment.

Last year, the hospital hosted 14 observership candidates:

Dr Kalliee Vibha Devi, MD (Medicine), from Mauritius, completed a week's observership.

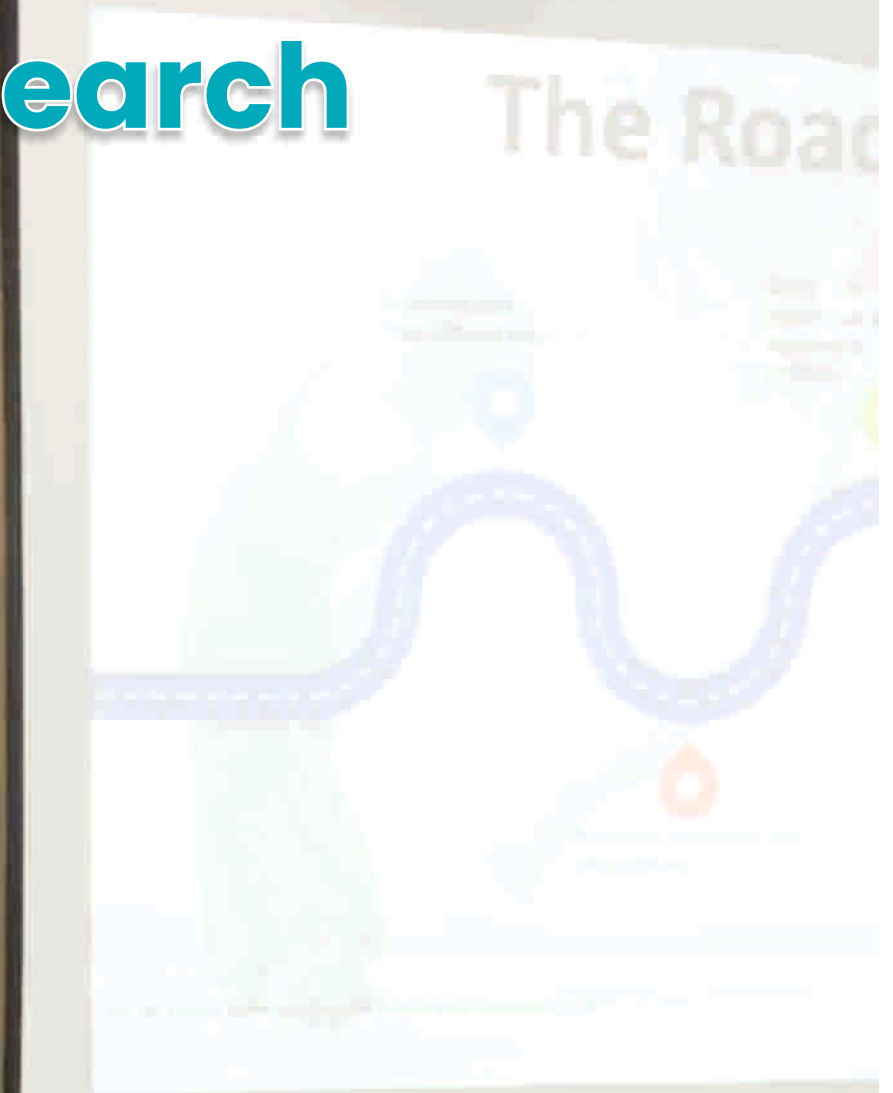
Maya Dangi, a pharmacist from New Delhi, underwent six-weeks training in nursing and physiotherapy.

NABH Update

J Watumull Global Hospital & Research Centre held a pre-entry level accreditation at the start of FY23. The certification was valid until April 28, 2023. In September 2022, the hospital applied for the full NABH accreditation programme (5th edition).

The preparation involved updating the existing NABH standards, policies and standard operating procedures (SOPs), and conducting training, mock drills, top table exercises and committee meetings.



The desktop assessment covered 800 questions. The identified non-compliances were then responded to, and those responses were reviewed. The three-day onsite assessment happened thereafter. Some non-compliance issues identified during this assessment were immediately addressed. As a result, the hospital had 269 SOPs, 33 clinical guidelines, nine clinical procedures, one apex manual, one drug formulary, one antibiotic policy and an updated hospital organogram.

NABH training includes 13 types of programmes (Code Blue, Code Red, Code Pink, Code Yellow,



HAZMAT drill, safe transfer of patient, care of vulnerable patients, HIC standard precaution/barrier nursing, continuous quality improvement, human resource management, management of medication, scope of service, patients' rights & responsibilities, safety and security of patient data), 12 types of committee meetings, mock drills etc. as per the NABH calendar.

The assessors were retired Air Commodore Dr Mehar Kumar Bedi (principal assessor), Jini Pillai (assessor) and Dr Amar Shah (assessor). Their comments are noteworthy:

Jini Pillai (edited)

You have a transparent nature. Everyone should be part of quality, otherwise quality will not happen. Quality is teamwork.

Dr Amar Shah (edited)

Remember this is a journey and every year you have to go through some kind of assessments like NABH desktop assessment, surveillance assessment, surprise visit etc. This NABH necessity should be in your routine practice. Whatever you are doing just document it.

Dr Mehar Kumar Bedi (abridged)

In India this is the first and only one hospital where I have seen a least number of non-compliances. So congratulations to you all and particularly to the quality team who worked day and night. Your quality team is very proactive.

The government

The Global Hospital & Research Centre trust partners the Government of Rajasthan to implement the Mukhyamantri Chiranjeevi Swasthya Bima Yojana, a state-sponsored health insurance scheme for the poor. Beneficiaries are eligible for free treatment up to Rs 500,000 in affiliated hospitals. Both J Watumull Global Hospital & Research Centre and the Radha Mohan Mehrotra Global Trauma Centre are affiliated hospitals. At the former, 1,899 patients were admitted over the course of the year while 4,103 patients took benefit at the latter.

The Global Hospital & Research Centre trust partners the central government for the implementation of the National Tuberculosis Elimination Programme, previously called the Revised National Tuberculosis Control Programme, the country-wide initiative to reduce the burden of tuberculosis by 2025, five years ahead of the Sustainable Development Goals.

The government incentivises field workers for handholding patients who fully recover, and reimburses some of the costs the partner incurs to get patients investigated and monitored through the course of treatment. The

government also provides medication for no charges. Tuberculosis activities have been reported in the chapter Community Vision.

J Watumull Global Hospital & Research Centre, Global Hospital Institute of Ophthalmology and Shri Adinath Fateh Global Eye Hospital implement the National Programme for Control of Blindness, the central government's initiative to eradicate preventable blindness occurring from diseases like cataract. Government estimates suggest that thousands of people with mature cataracts in Rajasthan and other states need surgical intervention. To serve these

people, the central government has partnered with private health providers like the Global Hospital & Research Centre trust to run screening programmes in villages to identify needy patients, provide them transport to the base hospital, operate on them and drop them back home. The government pays a part of the cost of such cataract operations.

Last year, the trust performed 1,066 operations on patients falling under the District Blindness Control Society Jalore and 1,545 operations on patients falling under the District Blindness Control Society Sirohi.

Organisations that have empanelled the hospital to care for their employees

Being the largest multidisciplinary hospital in district Sirohi, J Watumull Global Hospital & Research Centre has been enlisted as a treatment centre for beneficiaries of the Employees State Insurance Corporation (ESIC). Last year, 295 employees of commercial establishments claimed the cost of their treatment in the out-patient department, and 117 employees who were hospitalised claimed their treatment cost. Most beneficiaries of the ESIC are employees of hospitality establishments in the town.

J Watumull Global Hospital & Research Centre is also an empanelled private hospital to deliver allopathic and AYUSH medicare to former service personnel and their dependents, under the Ex-Servicemen Contributory Health Scheme (ECHS). Six patients were admitted in this category last year.

Employees of the Central Reserve Police Force (CRPF) also benefit from J Watumull Global Hospital & Research Centre being an empanelled private hospital for their cadres.

Radha Mohan Mehrotra Global Hospital is enlisted as a private treatment provider for employees of the North Western Railways and their dependents. Last years' beneficiaries numbered 1,008.

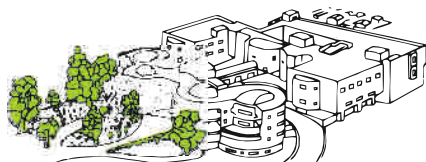
